Korea Immigration Service of the Ministry of Justice is currently running the Immigration Contact Center (also known as '1345') for the successful settlement of 1.7 million foreigners staying in Korea.



Immigration Contact Center

Also known as “1345”, the Immigration Contact Center provides comprehensive telephone counselling services to foreigners in 20 different languages including Korean, English and Chinese. The center offers valuable advice on immigration and daily-living tips to foreigners staying in Korea.

How to Call 1345

Whether using a landline telephone or personal mobile phone, you can call 1345 from anywhere in Korea without an area code.

(Please note, after 18:00 p.m., services are available only in Korean, English and Chinese)

• User Instruction for Auto-Response Services (ARS)

If you press 1, you will find locations, work hours, and areas of jurisdiction of all immigration offices.

If you press 2, you will find your visa application result.

If you press 3, you can announce retirement/resignation of your foreign employee as well as the place of employment of an H-2 Work and Visit status holder (overseas Korean).

If you press 0, you will be connected with a counsellor.

HiKorea; the e-government for foreigners

'The e-government for foreigners' ([HiKorea www.hikorea.go.kr](http://HiKorea.www.hikorea.go.kr)) is a multilingual online visa portal which provides valuable daily living tips and advice on immigration procedure to foreigners living in Korea. Foreigners can access the website in various languages, and request or file a petition on immigration-related-matters.

How to Check the Online Petition Process of Each Status of Stay

There are two ways to view or download the 'Visa Application and Sojourn Manuals' for each status of stay. First, you may click the notice board on HiKorea website, or second, you may browse through the menus located at the top of the webpage.

How to Submit Your Petition Online

In order to submit your petition online, you must sign up for the HiKorea website first before you click the online petition banner. When you click the online petition banner, a list of topics you can petition will appear. Then you click the topic of your interest, type your petition details and submit it online. If, in any case, the topic you want to discuss cannot be found on the list, please use the online reservation services to book a date and time to talk with an immigration officer in person.

The Republic of Korea's Visa Portal System

Through the Republic of Korea's Visa Portal System, a company as well as a university may apply for a confirmation of visa issuance or e-Visa on behalf of a foreign applicant it would like to invite. Since the Minister of Justice issues such documents directly online, the applicant does not need to visit a Korean embassy or consulate to collect those documents.

※ The formerly known as 'HuNet Korea System' is newly renamed 'the Republic of Korea's Visa Portal System'.

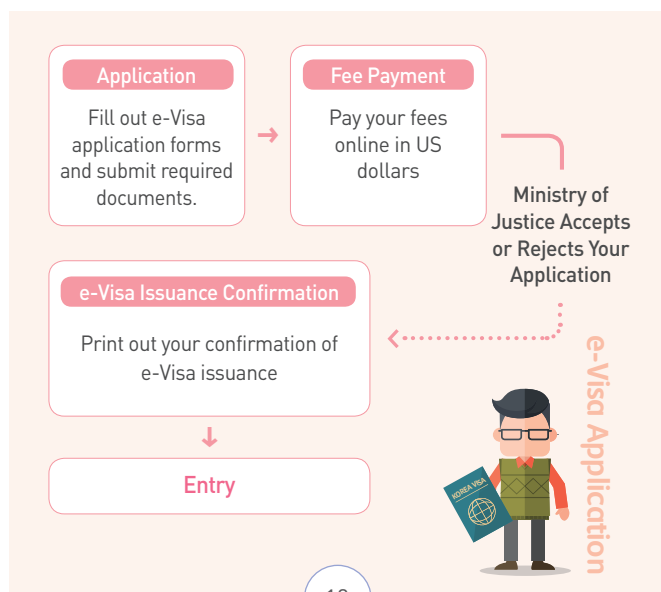

• How to Apply

- ① Sign up for the corporate membership at www.visa.go.kr, the Republic of Korea's Visa Portal.
- ② A jurisdictional immigration office will approve your membership.
- ③ Apply for an e-Visa
- ④ The Ministry of Justice will decide whether to accept your application.
- ⑤ (If accepted) Print out your confirmation e-Visa issuance (Your invitee must print it as well).
- ⑥ The invitee arrives in Korea.

Immigration & Social Integration Network

The Immigration & Social Integration Network (www.socinet.go.kr) allows users to apply for the Korean Immigration and Integration Program, International Marriage Guidance Program, and Migrants Early Adjustment Program (a.k.a 'Happy Start Program'). They can also check whether they have successfully earned the credits and completed the programs.

Mobile Immigration Services

Mobile Immigration Services are available for those who live far away from a local immigration office such as foreign employees, marriage migrants, and international students living in rural areas. Immigration officers regularly set up a temporary immigration office near where the aforementioned foreigners live, in order to make their services more accessible.

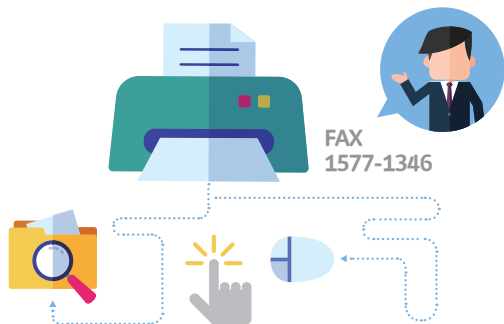

Fax services are available for any of the followings.

- Notification of Change in Employment/Training (students are NOT included) : within 15 days from the date of change (by employer)
- Notification of Change in Alien Registration Information
 - ➔ All information except when the alien registration card needs to be re-issued due to changes in your name, date of birth and nationality
 - ➔ Commencement of Employment and Change in Place of Employment for overseas Korean : within 14 days from the date of commencement or change (for H-2 Work and Visit status holders only)

- You can fax us from anywhere in Korea.

Notes

- You should always keep your passport and alien registration card (resident card) with you.
- You should always request for an extension of stay BEFORE your current period of stay expires. (You become eligible to apply for the extension from 2 months before the expiry date of your period of stay)
- You should always obtain permission for 'change of status of stay' in advance from the Minister of Justice if you intend to engage in activities other than those allowed by your original status,
- You should always obtain 'permission to engage in other activities' in advance from the Minister of Justice if you intend to keep your original status of stay while engaging in activities other than those allowed by your status,
- You should always notify an immigration office if there is a change in your place of residency (place of living) and alien registration information (full name, date of birth, passport number, etc.) within 14 days from the date of change.
- Employer should always notify an immigration office if there is a change in his/her foreign employee within 15 days from the date of change. (Employer Responsibility)
- A foreigner born in the Republic of Korea must apply for his/her status of stay within 90 days from the date of his/her birth.




